

# Stated Meeting Tuesday, December 5, 2023 John Knox Presbyterian Church, North Canton, Ohio and via Zoom 6:00 P.M. to 7:30 P.M.

Rev. Matthew Skolnik, General Presbyter, welcomed everyone to the meeting at 6:00 P.M. He explained that the entire meeting would be held in the sanctuary and the docket was online. Worship materials will be on the screens and attendees can use their phones, tablets, etc.

## TIME OF WORSHIP:

Rev. Joe Svancara opened worship with the Call to Worship from Isaiah Chapter 60. The hymn, "Prepare the Way" was sung. Rev. Justin Hylden read the scripture from Malachi 3:1-4 followed by a brief meditation. Rev. Kathryn Ophardt read the scripture from Luke 1:46-55 on "Mary's Magnificat" followed by a brief meditation. She then explained that there were three (3) stations on the way to the Communion Table for all to participate. One was the Christ Candle in the Advent Wreath, with another viewing different pictures of Mary "Visio Divina" and the final station was to burn an idol one may have written on a piece of paper in the fire pit set up outside the church building. Karol Niehaus, CRE led communion, followed by the closing hymn of "Canticle of the Turning." Rev. Erin Guzman led the Benediction. All participants were members of the First Pastor's Cohort.

### **BUSINESS MEETING:**

MVP Moderator Ruling Elder Jim Arganbright welcomed everyone and opened the stated business meeting with prayer.

#### **MOVING THE CHURCH FORWARD**

Rev. Matthew Skolnik, GP

- Discussion was held on the Book of Order Section G-2.10 regarding Commissioned Ruling Elders. GP Rev. Skolnik talked about the need for training Ruling Elders to be available to lead Communion at churches in the presbytery in addition to their own church as a member.
- G-2.1001 Functions When the presbytery, in consultation with one or more sessions or other responsible committee, determines that its strategy for mission requires it, the presbytery may authorize a ruling elder to be commissioned to limited pastoral service as a commissioned pastor also known as commissioned ruling elder as assigned by the presbytery. A ruling elder so designated may be commissioned to serve one or more validated ministries of the presbytery. The Presbytery, in its commission, may authorize the ruling elder to moderate the session of the congregation or congregations to which he or she is commissioned, to administer the Sacraments, and to officiate at marriages where permitted by state law. This commission shall also specify the term of service, which shall not exceed three years but shall be renewable. The presbytery shall review the commission at least annually.
- Rev. Skolnik also reviewed the upcoming Ruling Elder Enhancement Workshops that
  will take place in 2024. The schedule is on the Presbytery website. Any Ruling Elders
  are encouraged to take as many of the workshops that may be of interest to them. They
  will be held on Saturdays during the coming months at the First Presbyterian Church in
  Uhrichsville. Completed workshops will count toward Commissioned Ruling Training.

Moderator Elder Jim Arganbright asked for a **motion** to approve the Muskingum Valley Presbytery stated meeting minutes from September 23, 2023.

Moderator Elder Jim Arganbright asked for a **motion** to approve the Muskingum Valley Presbytery called meeting minutes from November 8, 2023.

Ruling Elder Alison Blondheim, Stated Clerk led the next portion of the business meeting.

Motion coming from the Session of First Presbyterian Church of New Philadelphia to extend the term of current Deacon Jackie Stutz in the office of Deacon for the Class of 2026. This is deemed necessary due to lack of qualified or interested individuals to serve.

**MOTION** Approval to allow Jackie Stutz, a Deacon of First Presbyterian Church of New Philadelphia to serve as Deacon for the Class of 2026. **APPROVED** 

Motion coming from the Session of First Presbyterian Church of Perrysville requesting that the Session term limit of no more than six consecutive years (G-2.0404) be waived for Elder Kathy Davis. The Session is requesting that she be allowed to serve for another term ending December 31, 2026. This is deemed necessary due to lack of qualified or interested individuals to serve.

**MOTION** Approval to allow Elder Kathy Davis of the First Presbyterian Church of Perrysville to serve an additional term as Elder for the Class of 2026 since she has already served two consecutive terms as Elder. **APPROVED** 

Motion coming from the Congregation of Christ Presbyterian Church of Canton who met on May 7, 2023, and voted unanimously to accept the planned retirement of Rev. David de Vries effective May 30, 2024, and to begin the process of dissolving his pastoral relationship with the church.

**MOTION** Approval to accept the retirement of Rev. David de Vries from Christ Presbyterian Church of Canton effective May 30, 2024. **APPROVED** 

Following this motion, there was a laying of hands and prayers offered by those present at the meeting for Rev. David de Vries.

The website portal will be open from December 1, 2023, through February 15, 2024, for individual churches. After that, you will need to provide Alison with your statistics so that they can be input.

We will also want your Necrology Report for 2023. This would be any Elders or Deacons that passed away in 2023 that were members of your congregation and any Pastors that are still part of our Presbytery and served or formerly served your congregation. The names will be remembered at our February 10, 2024, MVP Stated Meeting.

## **Boundaries Training**

Reminder to all Pastors (both ordained Teaching Elders and Commissioned Ruling Elders) that if you did not complete Boundaries Training in 2023 due to scheduling conflicts, you will need to complete it in 2024. Synod of the Covenant will again offer the training approximately three (3) times in 2024. This is required every three (3) years per the Book of Order, but Muskingum Valley Presbytery requires it every two (2) years.

# **Commission on Preparation for Ministry (CPM)**

Edith Ophardt, who Chairs CPM reported that the First Call Cohort led by Rev. Ben George continues to meet regularly. She thanked them for leading worship this evening.

Na Yang and Tim Pollock, CRE continue with their seminary M.Div. studies.
