Clerks of Session or whomever is responsible for entering the statistics in the online Statistics Portal will have from January 2 – February 15, 2025. After that you will have to submit your church's statistics to Alison Blondheim, Stated Clerk to enter for you. We will send out an email relating to this later in December.

- **December 2, 2024:** Statistics entry tools will open for presbyteries.
- January 2, 2025: Statistics entry tools will open for churches.
- February 15, 2025: Last day the statistics entry option will be available to churches.
- **February 15, 2025:** Minister summary reports along with all minister change forms relating to 2024 actions due. (This will permit production of Minister ID cards in mid-February.)
- March 3, 2025: Synod/presbytery miscellaneous and mid council cost forms due.
- March 3, 2025: Last day the statistics entry option will be available for presbyteries. No late statistical reports will be accepted after this date.
- March 15, 2025: Church summary reports along with all church change forms relating to 2024 actions due.
